### **TERMS & CONDITIONS**

#### ***Image Loan & Reproduction***

The *Waddesdon Manor Picture Library* is lending the *Client* the property described in the Contract under the following *Terms & Conditions*:

- i. Copyright of the image/s supplied to the *Client* is owned by *The National Trust, Waddesdon Manor*.
- ii. The acknowledgement for the image/s supplied to the *Client* must include *Waddesdon, The Rothschild Collection (The National Trust)*, the photographer's name, and the description/s of the image/s as supplied in the Contract, unless stated otherwise.
- iii. The image/s supplied to the *Client* remains the property of *The National Trust, Waddesdon Manor*
- iv. The image/s must be returned by the date indicated in the Contract. Failure to return the material by this date will result in an excess hire fee of £100 per month or part month. If the *Client* requires the image/s beyond the date specified in the Contract they must apply, in writing, for an extension no less than two weeks before the Contract is due to expire.
- v. Reproduction rights are granted for the purpose/s described in the Contract only and for no other purpose whatsoever. If the *Client* is discovered to have reproduced the image/s in any other way than that which has been agreed it will be considered a breach of contract and a penalty fee will be charged.
- vi. The *Client* will not use the image/s to support any cause or in any way which may be defamatory or reasonably anticipated to compromise the reputation of *The National Trust* or imply that it uses, approves or endorses any cause or commercial commodity.
- vii. In the event of loss or damage to the image/s supplied the *Client* will be liable to pay the following fees:
  - a) £450 for each original colour transparency
  - b) £100 for each duplicated colour transparency
  - c) £20 for photographic prints
  - d) £20 for image/s supplied as digital files on compact disc
  - e) £15 for each 35mm colour slide

*(The cost of replacing captioned mounts are included in the fees)*
- viii. Immediately upon completion of the work/s for which the reproduction has been granted the *Client* will supply one specimen copy of the publication.

#### ***Image Purchase***

The *Waddesdon Manor Picture Library* is selling the *Client* the property described in the Contract under the following *Terms & Conditions*:

- i. Copyright of the image/s supplied to the *Client* is owned by *The National Trust, Waddesdon Manor*.
- ii. The image/s are sold on the understanding that they are for research and/or lecture purposes only. Reproduction of the image/s supplied to the *Client* is forbidden without first applying for Reproduction Rights for which a fee will be payable.
- iii. The *Client* will not use the image/s to support any cause or in any way which may be defamatory or reasonably anticipated to compromise the reputation of *The National Trust* or imply that it uses, approves or endorses any cause or commercial commodity.
