Before you enter, please make sure you have read the entry process and competition terms and conditions.

### About the Competition

- The Chilli Fest Photography Prize encourages entries from professional, amateur and young photographers.
- The competition seeks to capture the essence of our Chilli Fest (1-2 September 2018).

### Prizes and benefits

- Credited images included in future Chilli Fest promotional material and on the Waddesdon website

**Closing date for entries is Sunday 16 September 2018.**

## Competition Rules

### How to enter

- Entrants should register their interest by emailing [chilli@waddesdon.org.uk](mailto:chilli@waddesdon.org.uk) before 5pm on Friday 31 August. Competition entry is free, however normal grounds admission apply.
- Registered entrants should check in on arrival between 10am and 11am at the information point at the entrance of the festival in the Aviary gardens to receive an official photographer lanyard and badge.
- There will be signage on site notifying visitors that photography will be taking place, however if photographing individuals, especially children, you must ask permission of the person(s) or in the case of children the responsible adult or parent. We will provide model release forms to be signed for these circumstances.
- After the event, images should be sent to [chilli@waddesdon.org.uk](mailto:chilli@waddesdon.org.uk) using a file sharing software such as dropbox, mailbigfile or equivalent link to the images. Please note that all images you wish to enter into the competition must be submitted at the same time.
- When uploading your images, please ensure your files are saved as your name, then an underscore followed by Chilli Fest, underscore and the title of your image eg – **jacksmith\_chillifest\_imagetitle**. This title will be used in any promotion of the competition so make sure it is creative and represents the image.
- Rothschild Waddesdon Limited cannot be held responsible for emails that do not arrive due to an entrant's email security settings or restrictions placed by their internet service provider.
- The competition is not open to employees or volunteers of Rothschild Waddesdon Limited or Rothschild Foundation Waddesdon.

### What to enter

- Each entrant may submit a maximum of **five (5) images** into the competition.
- Images submitted should be innovative and creative
- Images should be full colour
- Digitally enhanced/manipulated images will be accepted
- Entries must be digital files.

- For initial entry, all images must be submitted as JPEGs, saved at a maximum of 5MB
- Entrants must also be able to supply a high resolution file, suitable for printing in all media and for inclusion in Rothschild Waddesdon Limited's promotional material, should their image be successful. The high resolution file should match the colour and cropping of the JPEG submitted at entry. This should be between 10MB – 20MB. This file can be submitted via file sharing programmes such as Dropbox when requested.
- Entrants must be able to supply the RAW file, original JPEG, or original transparency or negative for any image upon request.
- Photo ideas could include, but are not limited to; photographs of people enjoying themselves, eating shots, food and drink stalls, stall product shots, wine tasting, children's activities, music performers, dancing and group shots of people at tables.

### General

- It is up to each entrant to ensure they have read and obeyed the competition rules set out below.
- By submitting an entry, each entrant agrees to the competition rules and digital guidelines, and that their entry complies with Rothschild Waddesdon Limited's requirements.
- Any entry found not to comply with the competition rules will be disqualified.
- No allowances will be made in such instances and any prizes will be forfeited.
- The decision of Rothschild Waddesdon Limited on all matters relating to the competition is final and binding. No negotiation will be considered.
- Any external press reserve the rights to choose which images they decide to use to promote the competition. Rothschild Waddesdon Limited has no control over, or liability for, any decision such press may make to use (or not use) your image.
- Rothschild Waddesdon Limited reserves the right to select which images of all of those submitted will be used within any marketing or promotion of the competition internally. Winners and shortlisted images do not have automatic rights to be used in any print media.

### Judging the competition

- Rothschild Waddesdon Limited will appoint a panel of judges which will include representatives of Rothschild Waddesdon Limited and suitably qualified photographic experts.
- The panel will be required to agree to terms of conduct whilst ensuring the spirit of the competition is maintained throughout.
- All entries will be given an entry numbers and judged anonymously
- The grand title of overall winner of the **Chilli Fest Photography Prize** will be awarded to the single image judged by the panel to be the best.

### Copyright and reproduction

- Each entry must be the original work of the entrant and must not infringe the rights of any other party.
- Each entrant must either be the sole owner of the copyright or have secured the written permission of the copyright owner to enter the image into the competition and grants the Owners the rights detailed below.
- By entering the competition, each shortlisted entrant grants to Rothschild Waddesdon Limited an exclusive, royalty-free, and perpetual licence to reproduce, publish and communicate to the public by any means and exhibit their image(s) and copies of their image(s) in all media throughout the world in relation to Rothschild Waddesdon Limited and the work we promote, in particular within the exhibition including but not limited to all use in the context of:
  - o Judging the competition.
  - o Inclusion in Waddesdon Manor promotional, press and marketing materials
  - o Inclusion within the Waddesdon Manor websites

### **Digital Guidelines**

#### **General**

To ensure entries submitted comply with technical requirements, please follow the digital guidelines outlined below. We want entrants to be creative with their entries, but they should always be a truthful representation. And don't forget all entries must be digital files.

#### **Digital Specifications**

- For judging purposes: Save and upload a copy of your image as a JPEG, (5MB max). If shortlisted we will require a JPEG of 10MB-20MB to be submitted at a later date when requested.
- For printing and inclusion on our website: a high resolution image (JPEG) will be requested if your image is shortlisted. This should be 8-bit, Adobe RGB (1998) at 300ppi. 10MB-20MB.
